LOCAL TRAVEL DIRECTIONS

METRO (Orange Line)

Exit at the **Ballston Metro Station**. Take the escalator up to street level (corner of N. Fairfax Drive and Stuart Street) and turn right toward Stuart St. Cross over Stuart St, walking one block and cross over N. Taylor St and turn left. Our suite is located in The National Rural Electric Cooperative Association (NRECA) building on the corner of N. Taylor St and Wilson Blvd. Upon entering the lobby, take the elevators up to the 2nd floor - **suite #200**. If going to the 4401 Wilson Blvd. building, continue through the lobby, past the elevators to the other exit. Continue outside under the short covered walkway to the next building and take the elevators up to the 10th floor – **suite #1000**

Note: From Regan National Airport take the Blue Line to Rosslyn and transfer to the Orange Line in the direction of Vienna.

DRIVING DIRECTIONS

EAST – From I-95 / 395 North

Take the North Glebe Road Exit #7B. Follow to Wilson Boulevard (about 2 miles). Turn right on Wilson Blvd. Make your first left on N. Taylor Street. Our building is located on the corner of N. Taylor and Wilson Blvd., parking entrance is located on N. Taylor.

EAST – From National Airport

Follow signs to I-66 West (Front Royal). Take Glebe Road/Ballston Exit #71. At the light, turn left onto Glebe Road. At the third light, turn left onto Fairfax Drive, and at first light, turn right on N. Taylor. Our building is located on the corner of N. Taylor and Wilson Blvd., parking entrance is located on N. Taylor.

WEST – From Dulles Airport

Take Dulles Access Road East, which will run into I-66 East. Continue on I-66 to Exit#71 Glebe Road/Ballston. Stay straight and at the third light, turn right on N. Taylor St. Our building is located on the corner of N. Taylor and Wilson Blvd., parking entrance is located on N. Taylor.

ALTERNATE DIRECTIONS (HOV-2 Restrictions/Congestion)

EAST

Take George Washington Parkway (North). Get into left hand lane and merge onto Route 50 West. Exit Route 50 at 10th Street, and turn left on Wilson Blvd, then turn right onto N. Taylor. Our building is located on the corner of N. Taylor and Wilson Blvd.

WEST

Take Dulles Access Road East. Exit Chain Bridge Road (Route 123 East) Exit #19. Take right on Old Dominion Drive, then bear right onto Glebe Road. Turn left on Wilson Blvd. Our building is located on the corner of N. Taylor and Wilson Blvd – one block in from Glebe Road.

Note: I-66 is restricted to High Occupancy Vehicles, HOV-2 (2-persons per car) from 6:30am thru 9:00am East Bound & 4:00pm - 6:30pm West Bound.

AREA PARKING

Parking is limited in our building. Parking alternatives besides the Metro are; on-street *metered parking*, other *nearby building parking garages* (within 2 blocks), and parking is also available at the *Ballston Mall*, located across the street on Wilson Blvd.
